## PUBLIC NOTIFICATION OF PUBLIC HEARINGS TRANSPORTATION PLAN AMENDMENTS

Pursuant to the provisions of North Carolina General Statutes §160A-364 and to the Town of Apex Unified Development Ordinance (UDO) Section 2.2.11, notice is hereby given of public hearings before the Planning Board and Town Council of the Town of Apex. **The purpose of these hearings is to solicit and consider comments relative to text amendments to *Advance Apex: The 2045 Transportation Plan* and *Bike Apex: The Comprehensive Bicycle Plan*.**

The proposed text amendments to Chapter 6: Bicycle and Pedestrian Element of [Advance Apex: The 2045 Transportation Plan](#) and Chapter 3: Recommendations of [Bike Apex: The Comprehensive Bicycle Plan](#) are intended to clarify that street-side greenways are recreational facilities.
